#### **Old Business**

- a. The Ball Polisher has been purchased for \$600. Robson will reimburse the club for \$330. The unit should arrive the end of January.
- b. Hand sanitizer is now on the credenza for use by players.
- c. Review of various club issues.
  - i. Chuck introduced old and new board members and went over each member's duties.

- c. Chuck, the Facility Manager, is cleaning the pool tables and balls on Saturday morning with the help of Mary. He has another club member cleaning them during the week.

### Other Issues

- a. The Billiards Club will have a table for the "Rediscover Quail Creek" in the ballroom on Friday, February 7, 2020. Mary will sign the club up for this.
- b. The cleanliness of the room, e.g., the blinds, and the deteriorating condition of the chairs was discussed. We had the ongoing discussion of who should pay for what (club or POA), as many residents of Quail Creek, who are not club members also use the Billiards Room and equipment. Chuck will write a letter to the POA Board addressing these issues.
- c. Mike gave an update on his progress regarding ordering shirts with a club logo on them.
- d. The Board liked the idea of hooks under the wall counters where cue bags could be hung. Mike will write a letter to David Jones.
- e. Dennis led a discussion on the commitment of players who sign up for tournaments. This also elicited discussion of a permanent travelling team, and how the selection should be made.
- f. Mary will reserve the Conference Room of the Kino Center for the third Friday of each month from 1-3pm for the year 2021 on Tuesday, February 25, at 8am in the Ballroom.
- g. Jim said that he could do a Special Group Sign-Up online for intramural tournaments on our QCBC website, as well as add them to the calendar.
